INSURANCE COVERAGE FOR YOUR COLLEGE STUDENT



It is important to double check that your child is covered if living in a dorm or an apartment while away at college. Generally, your home or renters policy will extend

coverage, but there could be limitations or exclusions depending on the carrier. If your child is 24 and is a full time student living in a dorm or an apartment, they are no longer covered by your home or renters policy. Please contact us for more details.

It is also important to notify us if your child is away at college whether or not they take a car with them. There could be potential rate discounts or changes depending on the situation.
