DECEMBER FREEZE HIGHLIGHTS THE NEED FOR AUTOMATIC WATER SHUT-OFF

The recent freeze in December reminded us that frozen pipes can cause a mess and over \$20,000 for the average claim. We recommend all homeowners consider a Phyn Plus to be installed in their home. It monitors your water usage, and if a pipe burst, washing machine leaked, or water heater busted it would notify you via your cell phone, and then turn the water off automatically minimizing the damage. It has an interactive app that shows your water usage. You can purchase the device for \$500, and then hire a plumber to install it for about 1 hour labor.
