**REMEMBERING KRIS O'NEILL**



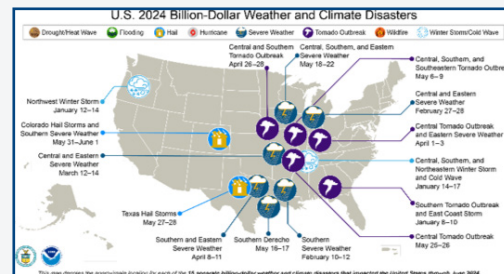

**WIND & HAIL DAMAGE CONTINUE TO RISE**

On average Ohio has about 21 tornados per year. As of June 10, Ohio has had 62 tornados and is only one more away from breaking the record in 1992. We continue to see a shift of tornados to move from the plains to the Ohio Valley. The last two years have been in the top 3 years of tornado activity.



**Top Ohio Tornado Years**

- 2024 – 62
- 1992 – 62
- 2023 – 60
- 2019 – 49
- 1973 – 48

As of 06/2024 there has been 15 Billion-Dollar Disasters totaling \$37.9 billion in claims. This is only second to June 2021 at \$44.0 billion in claims (CPI-Adjusted). We continue to see large storm claims, which will continue to drive home and business insurance premiums into 2025.
